Due to the current tower being unsafe Commissioner Simmons made a motion to move forward with the quote from Inter-County Communications, Inc. in the amount of \$59,995.00. Commissioner Gaskill seconded the motion and all members voted "aye".

WHEREFORE it is ORDERED, ADJUDGED and DECREED that motion to move forward with the quote from Inter-County Communications, Inc. in the amount of \$59,995.00 is HEREBY APPROVED.
