### 17. CONSIDER APPROVAL OF PURCHASE OF REAL ESTATE WITHIN THE CITY OF QUITMAN.

Commissioner Holland made a motion to acknowledge the \$50,000.00 Grant to Wood County from the Sabine River Authority Fiscal Year 2020 Community Assistant Grant Program. Commissioner Gaskill seconded the motion and all members voted "aye".
