**1. DISCUSS PROPOSED TAX RATE AND TAKE RECORD VOTE.**

Judge Hebron and Commissioners discussed the Proposed Tax Rate and took a Record Vote.

Commissioner Gaskill made a motion to set the Proposed Tax Rate at 0.5325. Commissioner Holland seconded the motion and all members voted "aye".
