Laura Wise, Elections Administrator, gave an overview of the License Agreement between Wood County and VR Systems and the need of new polling pads due to the current polling pads would have updating issues. Ms. Wise also informed the court a portion of the cost would be reimbursed by Chapter 19.

After discussion of the court Commissioner Simmons made a motion to approve of the License Agreement between Wood County and VR Systems for new poll pads. Commissioner Gaskill seconded the motion and all members voted "aye".

WHEREFORE it is ORDERED, ADJUDGED and DECREED to set a Public Hearing for 9/5/23 and 9/19/23 for the adoption of the "Wood County, Texas Tax Abatement Guidelines and Criteria" is HEREBY APPROVED.
