Commissioner Acker seconded the motion and all members voted "aye".

WHEREFORE it is ORDERED, ADJUDGED and DECREED that the pharmacy benefit, for Wood County, Texas, changing from Elixir Rx Solutions to ClarityRx Solutions – MagellanRx upon the County Judge signing the contract when received and to be in effect on April 1, 2024 is HEREBY APPROVED.
